Attendance Policy:

To be marked present for a scheduled school day, a student must:

- be on or ahead of pace in all courses and be passing all courses based on the “actual grade.”

OR

- login for at least a cumulative amount of time equivalent to 1 hour per assigned course for the day (i.e. 4 courses must have an active login time of at least 4 hours)

If the student does not meet the requirements listed above, the student may be marked absent for the given school day.



Academic Standing:

Students may be required come into the building for in-person structure/support in their virtual courses if:

- Student is failing 50% or more of their courses (based on “actual grade”)

AND/OR

- Student has fallen more than 20% behind pace in a given course.

Students being required to attend in-person will need to commit to either a ½ day AM or ½ day PM, providing they have their own transportation. Students can attend the full day in person by choice or if they need transportation both to and from school.
